BACKGROUND

APPO

(APPA) which was the precursor to (APPO) was created in 1987 by eight oil and gas producing Africa countries, with the modest aim of providing a platform for cooperation, collaboration and exchange of information on oil and gas among their members. The founding members were Algeria, Angola, Benin, Cameroon, Congo, Gabon, Libya and Nigeria

ORGANIZATION

The Organization has since added 10 full Members (Chad, Cote d'Ivoire, Congo DR, Egypt, Equatorial Guinea, Niger, and South Africa; and after the Reform Ghana, Namibia and Senegal joining the Organization in 2022 and 1 Honorary (Venezuela) making 18 full members

HEADQUARTERS

With Headquarters in Brazzaville, APPO went through major reform and restructuring in 2019, in response to the global paradigm shift on energy transition, resulting in major changes in its organizational structure, and a redefinition of its mandate












OBJECTIVE

Objective is to provide a platform for cooperation and harmonization of efforts, collaboration, sharing of knowledge and skills among African oil producing countries

THE ORGANIZATIONAL STRUCTURE OF APPO

The organization comprises the following decision-making and executive organs.

1a

The Decision-Making Bodies:

The Council of Ministers (the Council); Supreme policy and decision-making body of the Organization; made up of Ministers in charge of hydrocarbons or any official appointed as Head of a Member Country Delegation;

1b

The Executive Board; Made up of one representative per Member Country. The EB assists the Council of Ministers in the establishment of Strategic Orientations and overseeing the affairs of the Secretariat.

2

The Permanent Organ

The APPO Secretariat; Executive organ of the Organization, placed under the authority of the Secretary General, executes decisions and policies of the governing bodies.

3

The Specialized Organ

The Forum of NOC CEOs; They have the mission to foster collaboration on commercial, technical, and technology matters related to Hydrocarbons.
